Rules & Regulations:

1. Contestant must reside in Ritchie, Pleasants, Tyler or Doddridge County
2. All contestants must maintain a 2.0 GPA
3. Contestant cannot be currently married, have been married or had a marriage annulled. Also, must remain single throughout their reign.
4. Cannot be currently pregnant or have ever borne a child.
5. Entries, Picture (no larger than 5x7) and entry fee must be enclosed and postmarked no later than August 15th. Mailed to PCRFB Pageants c/o Terrie Swathwood – P.O. Box 213 Smithburg, WV 26436
6. Age Requirements (on day of Pageant):
Jr Miss – at least 13 and no older than 16
7. Should attend Orientation to receive rehearsal schedule on August 18th at 6:30 pm at Pennsboro Depot – Pictures will be taken for Newspaper at this time. You will need to have a question ready for your index card – these will be the fish bowl questions for on-stage. If you are unable to attend – you must notify the Director in advance.
8. Entry Deadline: Postmarked on or before – August 15th.

Jr Miss Competition Phases:

Opening Number – Should wear their Express yourself outfit – No scoring.

Express Yourself – this outfit should express the person that you are! It can range from Jeans to cocktail dress.

Personal Interviews – You should wear an Express yourself outfit (you can have two different outfits one for stage and one for interviews) No props.

Party Wear – this is a dress of your choice there will be 3 questions from your fact sheet along with one question from either another contestant – the reigning Jr Miss or the Pageant Director. (Floor length dresses will be allowed this year)

SPORTSMANSHIP CONTRACT

If I am crowned 2016 Junior Miss Vera on August 27th, I agree to uphold my obligations as listed below.

- To represent the Country Roads Festival as Visiting Royalty as often as possible.
- To cooperate with the pageant committee. I will notify the committee of upcoming events that I plan to attend.
- Not to enter or participate, as a contestant, in any pageant or contest during the term of this agreement. I further agree to relinquish any titles I now hold other than this particular one. I understand that the Cash Award will not be distributed until completion of my reign as 2016 Junior Miss Vera. (this will hold so for the runners-up also).
- If a Runner-Up I agree to participate in the Festival Parade in order to obtain my Award. (If obligations prevent this I agree to contact the Pageant Director)
- I attest that I am a citizen of the United States of America and a legal resident of the State of West Virginia.
- I agree to reign over the Pennsboro Country Roads Festival and participate in all activities required by said event and committee.
- I understand that I must have at least a 2.0 GPA to be eligible to receive the Award.
- I attest that I am of good moral character; that I have not been convicted of any major crime; that I have not heretofore made any obligations that would prevent or limit my participation as 2016 Junior Miss Vera and that I am not a current titleholder nor have been Junior Miss Vera.
- I understand that my reign will not be complete until the crowning of 2016 Junior Miss Vera.
- I understand that if I break any of the covenants herein, I may be removed and replaced as the 2016 Junior Miss Vera.

With my signature I certify that I have read this agreement and understand it. I further understand that in the event I do not fulfill any of the above agreements, unless extenuating circumstances prevail, the committee shall have the right to terminate this agreement and 1st runner-up will be appointed as successor.
